No consent or waiver, expressed or implied, by any party hereto of or to any breach or default by any other party hereunder shall be deemed or construed to be a consent or waiver of or to any other breach or default hereunder of the same or any other obligations of such parties.
- 6. <u>Entire Agreement</u>. This Agreement contains the entire understanding of the parties and may not be changed or modified except by written instrument signed by both Lessor and Leasing Broker.
- 7. **No Partnership**. Nothing contained in this Agreement shall constitute or be construed to be, or create a partnership or joint venture between Lessor and Leasing Broker, or their successors and assigns.
- 8. <u>Successors and Assigns</u>. This Agreement shall inure to the benefit of and be binding on the parties hereto and their respective heirs, successors, legal representatives and assigns.
- 9. <u>Governing Law</u>. This Agreement and the obligations of the parties hereunder shall be interpreted, construed and enforced in accordance with the laws of the Commonwealth of Kentucky.
